<u>Medical History</u> – Please inform doctor/technician prior to treatment if you have any of the following conditions that may make you unsuitable for LUMECCA treatments.

- o Pregnancy or nursing
- o Under 18 years of age (unless there is parents consent)
- o Permanent implant in the treated area such as metal plates and screws, silicone implants or an injected chemical substance
- o Current or history of cancer, especially skin cancer, or pre-malignant moles
- o Impaired immune system due to immunosuppressive diseases such as AIDS and HIV, or use of immunosuppressive medications
- o Severe concurrent conditions such as cancer, cardiac disorders, epilepsy, uncontrolled hypertension, and liver or kidney diseases
- o A history of diseases stimulated by heat, such as recurrent Herpes Simplex in the treatment area (prophylactic treatment may be given)
- o Any active condition in the treatment area, such as sores, psoriasis, eczema and rash as well as excessively/freshly tanned skin
- o History of skin disorders such as keloid scarring, abnormal wound healing, as well as very dry, cracked, ulcerated, infected and fragile skin
- o Tattoos, permanent make-up, pigmented lesions (to be kept)
- o Any medical condition that might impair skin healing
- o Poorly controlled endocrine disorders, such as diabetes or thyroid dysfunction
- o Any surgical, invasive, ablative procedure in the treatment area in the last 3 months or before complete healing
- o Use of Isotretinoin (Accutane ♣) within 6 months prior to treatment

0	Pigmented lesions will become darker for a period of 1-2 weeks before starting to lighten. Local inflammation around the lesions, manifested as some redness and swelling may accompany the response, as part of the healing process.
0	Blood capillaries will clot and appear darker for 1-2 weeks before disintegration. Some redness and swelling may accompany the response, as part of the healing process.
0	Some skin tightening may occur immediately, which may decline for 1-2 months, but will improve then, as new collagen fibers are produced.
0	All 3 lesions: brown, red and loose skin may improve simultaneously.
0	No complete clearance is guaranteed
0	Treatment requires a number of sessions
0	Exact number of sessions is individual
0	There may be some discomfort and transient redness and/or swelling associated with treatment There is a small risk of adverse reactions
0	 I understand that taking the treatment course is my choice and that I am free to withdraw at any time, without giving any reason.
	• I was told about the possible side effects of the treatment including: local pain, skin redness (erythema), swelling (edema), damage to the natural skin texture (crust, blister, burn), change of pigmentation (hyper- or hypo-pigmentation), and scarring. Although these effects are rare and expected to be temporary, any adverse reaction should be reported immediately.
	 I understand that I have to comply with treatment schedule, otherwise results may be compromised. I recognize that during the course of the procedure unforeseen conditions may necessitate different procedures than this above and I authorize the physician or assistants to perform such other procedures if they find them professionally desired.
